The purpose of this fact sheet is to inform internationally educated nurses of the fees they may incur during the credential assessment process in order to become licensed practical nurses in Manitoba.

## **Application Fees**

Please note that all fees are subject to change and the CLPNM does not determine third party fees (third party organizations are noted with an asterisk\*).

CLPNM Credential Assessment Application: \$315.00 includes GST

\*Language Scores: cost depends on the language test you take and location of test

\*Practical Nurse Qualification Recognition (PNQR) program:

- PNQR Program Application Fee: \$95.00 (This amount is not set by CLPNM; it is payable to ACC, and subject to change.)
- Course Fees: these amounts are not set by CLPNM; they are payable to ACC, and subject to change. Applicants may be required to take one to seven PNQR courses. Fees for individual courses range from \$150.00 to \$510.00.

The cost of the full PNQR program ranges between \$3880.00 to \$4400.00 (This amount includes tuition, books, and supplies and is not set by the CLPNM, and is payable to ACC.)

### \*Continuing Education:

 Course Fees: these amounts are not set by CLPNM; they are payable to ACC, and subject to change.
